Loup Basin Public Health Department ("we", "our", or "us") is committed to protecting your privacy. This Privacy Policy explains how we collect, use, and share your personal information when you visit our website, interact with us online or offline, or provide your information through forms, including those related to SMS communications.

1. What Personal Information We Collect

We may collect the following types of personal information:

- **Contact Information:** such as your name, phone number, email address, and mailing address.
- **Demographic Information:** such as your age, gender, or location.
- **Device Information:** such as IP address, browser type, and operating system.
- **Communication Preferences:** including SMS consent and opt-in status.
- **Any other information you provide voluntarily** via forms or communications.

2. How We Use Personal Information

We use your information to:

- Provide, personalize, and improve our services
- Respond to your inquiries and requests
- Send you updates, newsletters, and promotional materials (with your consent)
- Deliver transactional or service-related SMS messages
- Analyze website traffic and usage trends
- Comply with legal obligations

We **do not sell or rent** your personal information to third parties. We may share personal information only when necessary to provide services, operate our website and programs, or comply with legal requirements. This may include sharing information with:

- **Trusted service providers** who assist in operating our website or delivering our services (e.g., email platforms, cloud hosting), subject to appropriate confidentiality and data protection requirements.
- **Legal or regulatory authorities** when required or permitted by law.
- **Business partners** when specifically disclosed and with your permission.

SMS consent and messaging information are not shared with third parties for marketing or promotional purposes. For our SMS program, we may share this information only with service providers needed to operate the program, such as carriers and messaging platforms.

SMS consent is not shared with third parties.

We do not sell or share mobile numbers, SMS consent, or message data with third parties or affiliates for their marketing or promotional purposes. We may share this information only with service providers (e.g., carriers, messaging platforms) to operate our SMS program. Message frequency may vary. Message & data rates may apply. Reply STOP to opt out; HELP for help.

3. SMS Terms of Service

By opting into SMS communications from a web form or other medium, you are agreeing to receive text messages from Loup Basin Public Health Department. These may include SMS messages related to internal conversations (between employees) and external communications. Message frequency may vary.
